Varying your enrolment

Once your application to study a reduced load has been approved, you are required to make the necessary changes to your record through NAVIGATE.

Who should use this form?

You should use this form if you are studying in Australia on a student visa and want to enrol in less than the normal full time study load of 40 credit points because of either academic reasons or extenuating circumstances.

Students who have a 'Conditional Enrolment' and are enrolled in less than 30 credit points must complete this form.

You do not need to seek permission to study less than the full time load if you are in your last study session.

What are academic reasons?

Academic reasons can include, but are not restricted to, the following:

- a unit necessary for course completion is not available (not offered)
- timetable clash
- Advanced Standing is being processed
- a unit necessary for course completion is not available

What are extenuating circumstances?

Extenuating circumstances are those which are out of your control. You must be able to prove that this circumstance affected you personally and the impact is extensive enough to prevent you from studying a full time load for the relevant teaching session.

These are generally beyond the control of the student and have an impact upon the student's course progress or wellbeing. These could include, but are not limited to:

- serious illness, disability or injury, where a medical certificate states that the student was unable to attend classes
- bereavement of close family members such as parents or grandparents
- major political upheaval or natural disaster in the home country requiring emergency travel when this has impacted on the student's studies or
- a traumatic experience which could include involvement in, or witnessing of a serious accident; or witnessing or being
 the victim of a serious crime when this has impacted on the student. Such cases should be supported by police or
 psychologists' reports
- other exceptional cases students whose circumstances are outside the ones listed above should seek assistance from the Student Welfare Service or other professional services and attach supporting documentation obtained from them
